**I. Call to Order, Roll Call**

**II. Review, Consideration and Action on Complaints and Investigations**

Case No. 09-11      Lloyd Arnold, D.O. MD(H)

Mona Baskin, Assistant Attorney General (A.A.G.) provided an overview of a Consent Agreement and Order for Voluntary Revocation of License at Dr. Rowe's request. She indicated that Dr. Arnold had signed the agreement on May 25, 2010. The order will become effective when the Board approves its adoption.

Mr. Farris inquired whether Dr. Arnold could reapply for a homeopathic medical license. Mrs. Springer indicated that current board statutes preclude an application for five years and Dr. Arnold would have to also have an active D.O. in this state or another state.

Dr. Rupley made a motion accepting the Consent Agreement and Order for Voluntary Revocation of License. Mr. Farris seconded the motion that passed unanimously.
